# **Monday, June 13, 2022**

The Truth & Taxation Hearing of the Board of Education of Pellston Public Schools was held in the Gerald E. Mallory Board of Education Conference Room on Monday, June 13, 2022. Members present: Jim Milbrandt, Rob Thomson, Bryan Searles, Serenity Dankert and Stephanie Bromley. Members Absent: Kristen Bauer-Frye and Mark Zink.

The public hearing on the Truth & Taxation 2022-2023 hearing was called to order at 7:00pm.

The Pellston Board of Education proposes the following tax rates for the 2022 tax year of 18.000 operational mills (17.4060 & .5940) levied on non-homestead and non-qualified agricultural property and Sinking Fund mills of 1.9479 levied on all properties.

It was motioned by Rob Thomson and supported by Bryan Searles to approve the above Truth & Taxation 2022-2023 tax rates.

<u>2021-2022 Year End General Fund Budget Amendment Resolution – Version E</u> It was motioned by Stephanie Bromley and supported by Bryan Searles, "that the Board of Education, approve the 2021-2022 year end amendment to the General Fund Budget; and

therefore adopt the amended budget, as recommended administratively." The motion carried 5-0.

## General Fund Original Budget Resolution for the 2022-2023 School Year

It was motioned by Serenity Dankert and supported by Rob Thomson, "that the Board of Education, approve the 2022-2023 tax rates of 18.0000 operational mills (17.4060 & .5940) and sinking fund rate of 1.9479 levied on all properties and adopt the 2022-2023 Original Budget resolution, as recommended administratively." The motion carried 5 - 0.

## School Bus and Truck Purchase

The purchase of a school bus and truck are paused until July. A list of schools pre-qualified for free electric buses was recently released and Pellston is on the lists. Mr. Seelye and Lee have a meeting scheduled next week to gather more information. As for the truck purchase, Lee has done a great job researching options but is running into dead ends. MiDeal currently does not have any trucks available for order at this time. No action is requested at this time.

## Fire Truck Purchase for Public Safety CTE Program

Carp Lake Fire Department has a used truck for sale that Rob Thomson has researched and brought to Mr. Seelye's attention. Our Public Safety instructor, Duane St.Amour wants to add a fire truck to the CTE program and is going to look further into it. The cost is \$10,000 and can be purchased with CTE funding. No action is requested at this time.

#### Hall of Fame

Mr. Seelye led a brief discussion about the frequency of Hall of Fame inductions. Our Hall of Fame application currently states new members will be inducted every two years. The Board of Education wants to continue with this timeline. No action was requested at this time.
