#### 2019-2020 Budget Presentation

Kris Vizina presented an updated budget for the 2019-2020 school year. Kris will continue to provide budget updates regularly throughout the year. Mr. Seelye recommends adopting this amended budget to paint a clear picture of our district's finances. It was motioned by Mark Zink and supported by Bryan Searles to adopt the amended budget. The motion carried 6-0.

## Athletic Budget

Following the updated budget presentation, Mr. Seelye encouraged board members to have a discussion about the athletic budget Mr. Sheick proposed at the last workshop. Mr. Seelye recommends adding the Athletic Budget as presented to the 2019-2020 budget. It was motioned by Mark Zink and supported by Serenity Dankert to increase the athletic budget by \$12,000. The motion carried 6-0.

# Sinking Fund Millage

Mr. Seelye is working to have solid numbers by our next board workshop at which time millage rates and length of term can be decided. A final decision will need to be made at the December regular board of education meeting in order to get it to the County Clerk in time for the March ballot. No action is requested at this time so further discussion can continue.

# Pre Labor Day Start

Mr. Seelye shared information about the Pre Labor Day Start Waiver available through the MDE and local ISD. The ISD will be holding a meeting/hearing where districts may request the ability to start before Labor Day. Mr. Seelye would need to explain the district's reasoning and provide documentation to the ISD to support a Pre Labor Day Start for Pellston Public Schools. Mr. Seelye would also need to meet with teachers to discuss a new negotiated contract for next year. No action is required at this time unless the Board of Education is not in favor of moving forward with this plan.

## Chrome Book Purchase

Following the budget presentation, Mr. Seelye and Mrs. Vizina shared a couple different sources of funding the district could use to purchase 130 new Chrome book devices. Mr. Seelye is waiting for pricing from the ISD and Mi-DEAL. Mr. Seelye recommends approving the purchase of 130 new Chrome Book devices for the MS/HS.
