<u>Bus Update and Gridlinx</u>- Mr. Seelye gave the Board of Education an update on the status of our EV buses. He also provided details about a grant with Gridlinx to deploy charger management software in the district. Mr. Seelye will provide an additional update once representatives from Gridlinx have been on site. No action was requested at this time.

<u>Roofs and Solar Projects</u>- Mr. Seelye provided the Board of Education with an update after meeting with an architect this afternoon about replacing both the Elementary and MS/HS roof. The district's Sinking Fund account has enough money for both major projects. Mr. Seelye shared his plan of

action, will put the projects out for bid and look for approval next month. He also shared an update regarding the possible solar project. No action was requested at this time.

<u>USDA Technology Grant</u>- Mr. Seelye provided the Board of Education with an update on the work that has been done to pursue the USDA Technology Grant. Mr. Seelye feels very optimistic about our chances of being awarded. No action was requested at this time.
